10. That all the conditions prescribed in the GOs and other orders which are not specified in this order shall be complied with.

11. That the school shall not be closed without giving notice both to the parents/D.E.O.and competent authority at least six months before.

12. That the school shall not be closed or permitted to be closed only from the date on which summer vacation is declared.

13. That the society shall submit proposal for renewal of provisional recognition sufficiently in advance i.e. at least six months prior to the date of expiry of the renewal.

14. That the management should maintain service registers in respect of all teachers.

The recognition now granted is liable for withdrawal by the competent authority for violating rules as prescribed in the G.O. 5th cited and instructions issued by the authority from time to time.
